- "2. That all political power is inherent in the people, and all free governments are founded on their authority, and established for their benefit; and, therefore, they have, at all times, an inalienable and indefeasible right to alter or abolish their form of government, in such manner as they may deem expedient",(florida constitution, 1845 article 1, section2)
- "20. That the people have the right, in a peaceable manner, to assemble together to consult for the common good; and to apply to those invested with the powers of government for redress of grievances, or other proper purposes; by petition, address, or remonstrance.", (florida constitution, 1845 article 1, section20),
- "27. That, should guard against transgressions upon the rights of the people we declare, that everything in this article, is excepted out of the general powers of government, and shall forever remain inviolate; and all the laws contrary thereto, or to the following provisions, shall be void.", (florida constitution, 1845 article 1, section27),
- "congress make no law respecting an establishment of religion or prohibiting its free exercise. It protects freedom of speech, the press, assembly, and the right to petition the government for a redress of grievances", (1st Amendment Constitution of the United States),

the constitution of the united states, first amendment, 1791,

continental congress,

on october, 14, 1774, the first continental congress issued the declaration of colonial rights and grievances that contained, "If money is wanted by rulers who have in any manner oppressed the people, [the people] may retain [their money] until their grievances are redressed, and thus peaceably procure relief, without trusting to despised petitions or disturbing the public tranquility,"

declaration of independence, 1776, magna carta, 1215, a divine right held by we the people,

sarasota county general jural assembly is a **reestablished**, unrebutted lawful body politic of sarasota county within florida, a free and independent nation-state,

finding of facts,

whereas the sarasota county general jural assembly (scgja) was reestablished to reimplement self government on april 11, 2023, (exhibit 1) and

whereas one primary function of scgja is to ensure all government offices have lawfully received delegated authority from we the people through the two constitutions, and

whereas any office without explicit delegated authority in writing is operating unconstitutionally, and

whereas one primary function of scgja is to monitor actions by all elected officials to ensure operating their offices with the delegated authority in compliance with both constitutions, and

therefore scgja is hereby establishing a baseline that all sarasota county elected officials are operating their offices within delegated authority from both constitutions, and

solution required (prayer),

now, therefore, the sarasota county general jural assembly, unrebutted body politic of the free nation state of Florida, with facts as presented here within, respectfully instructs the sarasota county school board to become constitutionally knowledgeable and,

Strict proof is hereby required:

produce; certified copy of oath of office,

produce; copies of any other oaths held by board member(s),

produce; certified copy of surety bond,

produce; evidence of delegated authority that establishes the ability to contract with a teachers union,

produce; certified copy of unencumbered property posted as security for bond, produce; a list of offices that you currently occupy, and produce; certified copy of sarasota county's school board's current, valid charter with bylaws on file with florida's secretary of state, produce; a list of all sources of revenue/compensation/grants of any kind, and produce; an organizational chart, operational budget, and produce; a certified copy of foreign agent registration, and produce; a list of all attorney's (BAR members) employed by sarasota county school board, and produce; evidence of the type of entity the school board is operating, and produce; evidence as to where does the School Board obtain lawfully delegated authority from we the people through the constitutions to establish any lawful taxes for funding public schools, and produce; evidence of any delegated authority to any government entity to operate our public schools or choose the curriculum for sarasota public schools, and required response; a written response revealing school board member's intent with projected time frame to complete requirements is needed within ten (10) days of receipt of this redress notice, printed autograph date Karen irwin scgja recsec post office box 461 englewood, florida [34295] printed autograph date thomas sikes moderator post office box 461
